- 1) declares to have read carefully in its entirety and accepted in full and without reservation the rules of the event;
- 2) declares to be fully aware of all the characteristics and specificity of the test, the track, the difficulties and the path length, which grows in the mountains with possible difficult weather conditions (such as, but not limited to, cold, wind, rain, snow, poor visibility, etc.). to be aware of the risks to the personal safety related to competition; to be an expert in competitive mountain running Outdoor Running Trail Running Skyrunning and aware that participation in this event requires specific preparation and a real capacity of personal autonomy which attests to possess;
- declares not to make use of performance-enhancing drugs and being in possession of medical certificate attesting to fitness to practice of sport, to be in good health and relieve the organizers from any liability related and consequent to establishment of the above fitness;
- 4) agrees to carry, throughout the duration of the competition, the following materials required, and exempts the organization in case of an accident or illness or any damage due to the lack of such materials are required: water reserve of at least 1 liter; food reserve; a glass 15cl minimum personnel, including water bottles; windbreaker waterproof / thermal; whistle; survival blanket; cell phone with a charged battery (in which category should be added to the security numbers of the organizers, and should not be masked the number of the athlete); identity document valid; accept checks of the materials required which may be made at any time of the race, declaring to be aware that the lack of even one of the materials required in the running may cause her disqualification and agree to the discretion of the parties involved in the control;
- 5) agrees to assume, under penalty of exclusion from the event, a behavior consistent with the principles of fairness and good sportsmanship during the race and not to assume, in any case, behavior contrary to the law and the rules of the Regulation may endanger the own or others' safety; is also committed to keep a respectful behavior during the competition environment, according to the "run without leaving dirty";
- 6) You assume all responsibility in both criminal and civil, even objective, following its participation in the event; states to raise the organizers from any liability, direct or indirect, for any damage to property and non-property, even future illnesses and / or injuries, which may he / she be suffered, suffered and / or caused to third parties, during the entire duration of the event and / or during and / or as a result of his participation in it; from any liability related to theft and / or damage that may be caused by any of its personal object, whose custody is aware that it is assumed by the organizers in any way; and all liability for any damage he / she caused to third parties and / or property owned by third parties.
- 7) claims to have received and understood fully the following information in accordance with article 13 of Legislative Decree No. 196/2003: the personal data of subscribers to the event are treated in accordance with Legislative Decree 30 June 2003, n. 196; personal data are collected at the time of registration and are supplied directly by the interested parties; failure to provide personal data makes it impossible to accept the entry itself; the data are processed in paper and electronic form by the organizers, for all matters relating to the organization of the event, in order to provide users with information about the participants and the results of the event; the same data can be communicated to employees, contractors, companies and / or companies involved in the organization of the event organizers and consultants for these purposes; in relation to any sensitive data it contains, members are asked to express their express consent for the processing of such sensitive data; is not provided for the communication, dissemination, transmission of sensitive data.
- 8) took note of the information referred to in the preceding paragraph, shall authorize the treatment and communication of your personal data for purposes related to the realization of the event and for the eventual publication of the results of the race; expresses its consent to the treatments specified in the authorizing the sending of informative material related to subsequent events or various initiatives proposed by the organizers and authorizes any photographic and film for the production of videos, message boards, print and web publication (including downloads).
